MEMORANDUM OF ASSOCIATION
OF
FUSION HALIFAX NETWORKING ASSOCIATION

1. The name of the Association is FUSION Halifax Networking Association.
2. On a volunteer and non-profit basis, the Association will seek to achieve these objectives:
 - (a) To improve the city of Halifax for young residents in areas including:
 - (i) Arts and culture;
 - (ii) Economic and workplace development;
 - (iii) Education;
 - (iv) Health and wellness
 - (v) Immigration and diversity;
 - (vi) Sustainability; and
 - (vii) Urban planning and design.
 - (b) To facilitate networking and discussion among young Halifax residents including the organization of action teams.
 - (c) To highlight and create social, volunteer, economic, leisure and cultural opportunities for young Halifax residents.
 - (d) To generally promote the affairs of the Association.
 - (e) To acquire by way of grant, gift, purchase, bequest, devise or otherwise, real and personal property and to use and apply such property to the realization of the objects of the Association.
 - (f) To buy, own, hold, lease, mortgage, sell and convey such real and personal property as may be necessary or desirable in the carrying out of the objects of the Association.

PROVIDED that nothing herein contained shall permit the Association to carry on any trade, industry, or business and the Association shall be carried on without purpose of gain to any of the members and that any surplus or any accretions of the Association shall be used solely for the purposes of the Association and the promotion of its objects.

PROVIDED further that if for any reason the operations of the Association are terminated or are wound up, or are dissolved and there remains, at that time, after satisfaction of all its debts and liabilities, any property whatsoever, the same shall be paid to some other charitable organization in Canada, having objects similar to those of the Association.

3. The activities of the Association are to be carried out in the Province of Nova Scotia and in any other place if such activities further the objectives of the Association.
