Every company shall have a registered office to which all communications and notices may be addressed.

Register of Mortgages & Charges


54. (1) Every limited company shall keep at its registered office in writing on Register of mortgages one or more sheets, whether bound or unbound, a register of all mortgages and charges specifically affecting property of the company, and shall enter in such register in respect of each mortgage or charge a short description of the property mortgaged or charged, the amount of charge created and the names of the mortgagees or persons entitled to such charge.

PART VI - Removal of Defunct Companies

156. (1) Where the Registrar has reasonable cause to believe that a company is Company not operating may be struck off not carrying on business or is not in operation, he may strike the company off the register register and the company shall thereupon be dissolved.

Company, creditor or 159. If a company or any member or creditor thereof feels aggrieved by the member may apply to company having been struck off the register in accordance with this Law, the court for company to be Court on the application of such company, member or creditor made within two years or such longer period not exceeding ten years as the Governor in Cabinet may allow of the date on which the company was so struck off, may, if satisfied that the company was, at the time of the striking off thereof, carrying on business or in operation, or otherwise, that it is just that the company be restored to the register, order the name of the company to be restored to the register, on payment by the company of a re-instatement fee equivalent to the original incorporation or registration fee and on such terms and conditions as to the Court may seem just, and thereupon the company shall be deemed to have continued in existence as if its name had not been struck off; and the Court may, by the same or any subsequent order, give such directions and make such provisions as seem just for placing the company and all other persons in the same position as nearly as may be as if the name of the company had not been struck off.
