It was in the late 1950's when Anthony Baldacchino ventured on a journey that today results in the flourishing businesses which are JP Baldacchino & Co Ltd and ASB Holdings Ltd.

Alert business acumen, hard work, prompt delivery and a reputation for fair dealing, were the key ingredients that stimulated the steady expansion of the business.

In 1974, the business was duly registered as a limited liability company. In fact, 2014 will mark 40 years since the establishment of JP Baldacchino & Co Ltd. Throughout these years the Company has marked itself as one of the leading suppliers to the construction industry, including steel and allied products, representing multinational companies such as Arcelor Mittal.

In 1980, the Company's activity was transferred to an ad hoc complex built on land bought by the Company on the Ghaxaq By-pass, comprising three spacious warehouses and adequate offices rooms. Through this, and other development the wholesale division was organized to cover the entire islands of Malta and Gozo, while the role as representatives for overseas suppliers was enhanced to a point where it became the core of the business.

For more than twenty-five years the firm operated from the Ghaxaq site, but continued expansion meant the need for a more dynamic arrangement optimising both the accessible footprint space and the human resources. Thus the need for bigger and more efficient premises was felt. After three years of construction and preparation, the "Ferrum House" premises, situated on the outskirts of Gudja, was inaugurated. The new site covers an area of more than five-thousand square metres. The eventual move to "Ferrum House" materialised in September 2005.

Nowadays, the Company is managed by Dennis and Adrian Baldacchino, being two of the sons of Anthony Baldacchino.
